A town budget and new commissioner

ISLIP TOWN—Last Thursday, the Islip Town Board unanimously passed its final 2016 budget, amounting to a total of \$221,282,681 and a tax increase of 0.73 percent, which falls under the state tax cap and will raise the average homeowners' property taxes \$19.15 per year. The board also unanimously passed a resolution appointing environmental engineer James H. Heil as the new commissioner of the Department of Environmental Control.

No residents registered to speak during the short public hearing, which lasted no more than a few minutes. Afterwards, Carpenter said that the lack of criticism was a testament to the “transparency” exhibited throughout the budgeting process, which included posting the budget online.

“An incredible amount of energy went into this document, and we really have tried to address the issue of transparency,” said Carpenter.

Meanwhile, Heil, a Shoreham resident, is set to commence his role on Monday, Nov. 16. He will fill the spot left open by Eric Hofmeister, who resigned from the town last month to work as former Islip Supervisor, now NYS Senator Tom Croci's district director.

Heil received his bachelor's degree from Manhattan College in 1962 and a Master of Science from New York University in 1969, both for civil engineering. He has an extensive resume that includes tenures as commissioner of sanitation in Brookhaven (1984-88) and commissioner of waste management in Brookhaven (1988-95). For the past 20 years, he served as an environmental engineer for Cashin Associates. In Islip, he will oversee a total of 104 employees for the standard commissioner salary of \$101,000 per year.

The DEC responsibilities include running the Resource Recovery Agency, the town compost facility, garbage collection, environmental initiatives, and the animal shelter.

Heil commented on his predecessor, noting, "He's going to be a tough act to follow. He was a great commissioner, and I hope I can succeed and carry forth what he's put in motion."

Carpenter referred to Heil as a "delightful gentleman," noting that he already has prior working relationships with Hofmeister and DPW/Parks Commissioner Tom Owens.

"His credentials are impeccable, and he is very well respected in the environmental community," said Carpenter, who noted that a total of five candidates were interviewed for the position. "He has experience working with a number of people our department interacts with, so I think it will be very helpful going forward. I'm excited, and he's going to do real well for us."

Overall, Heil said that he is excited to assume his new role within the town.

"The opportunity came up and I was fortunate enough to be selected. It's going to be a pleasure working for the Town of Islip. They have a good, solid waste program and I'm looking forward to getting started," he said.

Islip Town appoints new environmental commissioner

ISLIP TOWN—Last week, the Islip Town Board appointed a new commissioner for the Department of Environmental Control. Martin Bellew was named to head the department that oversees the town's handling of solid waste and recycling, as well as environmental protection and animal control programs.

Bellew, 63, is filling the vacancy that was left by James Heil, who retired earlier this week after nearly three years as commissioner of the department.

Bellew, a longtime Rockaway Beach resident, will be paid \$125,000 a year for his new post with Islip Town. He is currently an independent consultant, according to his resume, working with numerous engineering, solid waste and bio waste management companies.

Bellew briefly served as acting commissioner for the City of Yonkers' Department of Parks and Recreation, where he oversaw the daily operations and long-term planning for the city's 70 parks and playgrounds. Prior to this role, he served for seven years as deputy commissioner for the city, directing all public works operations.

He also worked for 22 years with New York City's Department of Sanitation, including six years as director of the bureau's waste disposal and solid waste engineering. It was here that he managed and implemented the transportation of all material from the World Trade Center cleanup to the Fresh Kills landfill on Staten Island. Bellew also managed the closure of the Fresh Kills landfill, which opened in 1948 and covers 2,200 acres in the New York City borough.

The new commissioner, who earned a Bachelor of Science in chemical engineering from the University of South Alabama, has also taken on Heil's role as president of the Islip Town Resource Recovery Agency, which provides solid waste management services to the town. He explained that he has a professional relationship with the previous commissioner, as they have both

served on the board of directors for multiple environmental organizations, including the New York Chapter of the Solid Waste Association of North America and New York State Association for Solid Waste Management.

As for Heil, the Islip Town Board thanked him for his service during last week's board meeting. Councilman John Cochrane added that Heil always "took the residents of Islip to heart."

The former commissioner oversaw plans for the new Islip Animal Shelter in Central Islip and improvements at the recycling facility in Holbrook, as well as the installation of solar panels at capped landfills in Hauppauge and Holbrook.

Heil previously retired in 1995 as commissioner of waste management for Brookhaven Town. He has reportedly stated that he will not collect another state pension for his most recent retirement.

Bellew is currently settling into his new position. When asked about the arguably long commute from Queens, he said the trip isn't too bad considering previous employment.

Suffolk DA: 7 arrested in bottle/can recycling scam

\$\$\$\$\$A scam to take advantage of the state recycling law by redeeming the same bottles and cans over and over again netted seven men millions and millions of dollars, Suffolk District Attorney [Thomas Spota](#) said Tuesday.

A yearlong investigation. The masterminds include Peter Sidote, 53, of Dix Hills, owner of Party Time beverage in Brentwood, and Joseph Luzzi, 60, of Bayside, Queens, owner of Boro Recycling in [Brooklyn](#).

The wholesalers then sent the cans and bottles to Boro Recycling, which was supposed to sell them to plastic, glass and aluminum companies.

But instead, Spota said, Luzzi sent the same shipments of crushed beverage containers back to Sidote, who would again take them to wholesalers and collect his handling fee. Luzzi and Sidote would then split the profit, Spota said.

Spota, who was joined by state Attorney General [Andrew Cuomo](#) at a news conference Tuesday at the district attorney's office in Hauppauge.

The operation, which Spota said went back several years, grew so big that Sidote recruited other beverage distributors to deliver already redeemed bottles and cans to wholesalers for a cut of the profit.

*****Spota said that investigators recovered more than \$1 million in cash at the homes and businesses of the seven suspects. All are charged with second-degree grand larceny, except for Lisi, who is charged with third-degree grand larceny. The men face up to 15 years in prison on the second-degree larceny charges.

On June 30, 2011, Mr. Sidote entered into a plea agreement with the District Attorney's office and signed a Settlement Agreement. In the plea agreement, Mr. Sidote pled guilty to grand larceny and scheming to defraud, and admitted the factual elements of the charges.
